## RESOLUTION 2021-2022 NO. 3 OPENING PUBLIC MEETING ACT (revised)

WHEREAS, the Open Public Meeting Act, N.J.S.A.-10:4-6 et seq, requires the adoption by a public body of a schedule of the regular meetings to be held during the calendar year; and

WHEREAS, upon proper notice under the Act given, no further notice of meetings will be necessary.

NOW, THEREFORE, BE IT RESOLVED, by the Plumsted Township Board of Education of the Township of Plumsted, County of Ocean and State of New Jersey, assembled this 4<sup>th</sup> day of May 2022, as follows:

Such meetings shall commence at 6:00 p.m. for public/executive session and 7:00 p.m. for public session and shall be held at the New Egypt High School IMC, 117 Evergreen Road, New Egypt, NJ 08533, unless otherwise noted.

A copy of all advance notice of special meetings of the Board of Education shall, at least 48 hours in advance of said meeting, be mailed to the newspaper designated in paragraph two (2) herein, filed with the Township Clerk of the Township of Plumsted, and posted at the following Location(s):

Bulletin board in the main offices of all Plumsted Township District Schools

2. The following newspaper, circulating in the Township of Plumsted is hereby designated the official newspaper for transmittal of all notices of the Board of Education required hereunder:

The Asbury Park Press  
The Trenton Times

3. Any person may request in writing that the Board of Education mail him/her a copy of the schedule of meetings of the Board of Education and/or advance written notice of regular, special or rescheduled meetings of the Board of Education.

Upon prepayment by such a person of the applicable fee hereinafter set forth, such schedule and/or notice shall be mailed to such person. All requests made pursuant to this paragraph shall terminate at midnight, December 31 of the current year, subject to renewal thereafter upon filing of a new written request to the Board of Education together with prepayment of the applicable fee. Notice requested by a news media shall be mailed to one representative of such media free of charge.

4. Upon affirmative votes of 3/4 of the members of the Board of Education present, the Board of Education may hold a meeting without compliance with the notice requirements of this resolution if such meeting is required to deal with matters of such urgency and importance that delay for the purpose of providing adequate notice would be likely to result in substantial harm to the public interest.
5. A copy of this resolution shall, within seven days, be mailed to the above named newspapers, the Township Clerk of the Township of Plumsted and posted as required for special meetings.
